The undergraduate program is currently transitioning away from Didactic Program in Dietetics (DPD) accreditation and is no longer accepting new students into the DPD program. The DPD program will be retired effective June 15, 2028, and currently enrolled students must complete all requirements for their degree before June 15, 2028, if they wish to receive a DPD verification statement. The BS Nutrition & Dietetics remains accredited as a DPD program by the Accreditation Council for Education in Nutrition and Dietetics (ACEND) through June 15, 2028. ACEND is located at 120 South Riverside Drive, Suite 2190, Chicago, Illinois 60606, (312) 899-0040, ext. 5400. www.eatright.org/acend. The program is reviewed and monitored by ACEND for assurance of quality dietetics education The DPD program at Olivet Nazarene University completed the most recent Selfstudy in 2018/2019. The ACEND Board voted to continue full accreditation of our program for a term of seven + year ending June 30, 2027 (extension request submitted to align with program closure date). Accreditation is granted for a Didactic Program in Dietetics at the baccalaureate level for a maximum enrollment of 12 third- and 12 fourth-year students.

Am I a Registered Dietitian Nutritionist (RDN) when I graduate with a dietetics degree from Olivet?

Current students who complete the DPD will receive a Verification Statement. The Verification Statement is provided by the DPD Director upon proof of program completion, including graduation with a BS in Dietetics. The Olivet graduation requirements for dietetics, which are the same for obtaining the Verification Statement from Olivet, are stated in the Student Manual

Students must also complete the master's application process. Acceptance into this step is competitive. Grade point average,

work experience and leadership qualities are considered.

Students must complete a Supervised Practice Program in addition to a master's degree requirement. Upon completion, the student must take and pass the Registration Exam for Dietitians given by the Commission on Dietetic Registration (CDR). At this step, the RDN credential is earned. See DI director & state regulatory agency for further licensure details.

Do I need a Master's Degree to become an RDN?

*"Effective January 1, 2024, the Commission on Dietetic Registration (CDR) will require a minimum of a master's degree to be eligible to take the credentialing exam to become a registered dietitian nutritionist (RDN). In order to be approved for registration examination eligibility with a bachelor's degree, an individual must meet all eligibility requirements and be submitted into CDR's Registration Eligibility Processing System (REPS) before 12:00 midnight Central Time, December 31, 2023. For more information about this requirement visit CDR's website: https://www.cdrnet.org/graduatedegree. In addition, CDR requires that individuals complete coursework and supervised practice in program(s) accredited by the Accreditation Council for Education in Nutrition and Dietetics (ACEND). Graduates who successfully complete the ACEND-accredited [program type] program at [Institution name] are eligible to [apply to an ACEND-accredited supervised practice program/apply to take the CDR credentialing exam to become an RDN].
