Understanding and Appreciating the Olivet Foundation

- The foundation funds nearly two million dollars annually to the University and directly to students, so it plays a very important role in keeping Olivet affordable and maintaining academic excellence.
- The \$40+ million foundation exists to generate a dependable stream of income to fund what matters most to you at Olivet Nazarene University. The University can count on this income every year into perpetuity.
- This stream of income comes from a permanent investment of donor gifts and equity in stocks, bonds, hedge funds, and private equity. It supports programs including scholarships, faculty positions, facilities, and more on an annual basis. The foundation also helps to fund general operations of the work of *Education with a Christian Purpose*. Notably, returns from the foundation decrease the amount students need to pay in tuition both now and for future generations.

Historical Note: in 1232, Alan Basset, an English baron, funded the first recorded endowed scholarship, at Oxford University with 200 pounds from his estate. Today, almost 800 years later, the endowment is still supporting Oxford.



The < Donor or Honoree > Scholarship At Olivet Nazarene University







Background:

EXAMPLE — Philip J. Meredith and Patricia L. Sparks were both born during the heart of the Great Depression (1933 and 1934 respectively) to dedicated Christian parents. Phil was born in Holland, Michigan, where his father was pastor of the Wesleyan Methodist Church. Pat was born in Jolietville, Indiana, where her father was pastor of the United Methodist Church.

Phil graduated from King's College with a degree in physical education, and Pat graduated from University of Wisconsin Stout with a degree in clothing and textile.

Phil and Pat met in Upland, Indiana, where Phil's father served as president of Taylor University and Pat's father served as pastor of the United Methodist Church and as the university pastor. Their marriage on June 7, 1955 has blessed them with more than 55 years together as best friends. They taught in school systems in Wisconsin and Hawaii, and then retired after teaching for 23 years in Joliet, Illinois.

While teaching and living in the Joliet area, Phil and Pat attended Chicago First Church of the Nazarene. In addition to their service to others through education, the Merediths participated in 10 Work and Witness mission trips — to Africa, Venezuela, Jamaica, Ecuador, Mexico, and Russia.

Following retirement in 1989, the Merediths moved to St. Simons Island, Georgia, where Phil enjoys playing golf while Pat pursues her love of working with textiles.

Because Phil and Pat have devoted their lives to education, sharing their blessings with Olivet students seemed a natural way to connect their passion with Kingdom work. Phil says, "Personally, I can't think of a better place to support than Olivet Nazarene University. It is a school that is providing our youth with the right education to have a Christian witness in the world." In addition to establishing this endowed scholarship, Phil served faithfully on the Olivet Nazarene University Foundation Board from 1994 to 2002.

Establishment of the Endowment:

Olivet Nazarene University Foundation established the < Donor or Honoree > endowed scholarship with a donation of \$ < Amount > by < Payment

Type > on < Date >. Additional annual gifts and/or a bequest may be added at the Donor's discretion.





In consideration of the Donor's gift, the Foundation agrees to administer this endowed scholarship in accordance with the requirements of this Gift Agreement. The Donor recognizes the right of the Foundation to accept gifts from other sources to increase this endowed scholarship, with the understanding that such gifts will not change or modify the name or purpose of the scholarship.

The Donor's gift shall be invested according to the University's policy with annual income earned from the investments utilized to support the scholarships. Under current Foundation guidelines, income distributions from endowed scholarships are equal to five percent of the three-year average market value of the endowment. This distribution is based on market conditions and may change at any time and without notice to the donor.

Purpose of the Gift:

With this gift, the Donor is creating a permanent endowed scholarship for the benefit of students at the University. Distributions from the endowment shall be made in accordance with the following guidelines:

Beginning in the fall of < Year >, scholarships will be awarded annually to worthy and needy students at Olivet Nazarene University, with a preference for < Criteria >.

Scholarships will equal \$ < Amount > per year until the standard distribution from the investment earnings exceeds this amount.

Recipients of the scholarships will be selected by a committee appointed by the directors of the Olivet Nazarene University Foundation.

Administration and Recognition:

The scholarship fund will be administered by the Olivet Nazarene University Foundation Board of Directors. The Foundation will certify that the appropriate awards have taken place and the Donor shall be notified annually of the name of the student(s) selected to receive *The Conor or Honoree Scholarship*. Appropriate publicity and recognition to the Donor shall be provided by the Foundation, unless anonymity is a condition of this agreement.

Investment and Minimum Funding:

The property comprising this gift may, for investment purposes, be merged with other Foundation assets but shall be recorded in the financial records as a separate endowed account. The investment committee of the Foundation will invest all assets in order to provide maximum earnings with minimum risk. Any surplus income from the endowed scholarship account not expended in a given year shall be returned to the endowment account's balance, less any administrative costs in effect at that time.



THE OLIVET FOUNDATION

Contingency:

The Donor acknowledges that all gifts accepted by the Foundation are subject to the general policies of the Foundation and the laws of the United States and the State of Illinois as they may exist from time to time. Further, the Foundation agrees that the wishes of the Donor with respect to the Donor's gift shall be loyally observed so long as the Donor's wishes do not conflict with the proper administration of the Foundation or the University. This scholarship program will be thoroughly reviewed at the end of 25 years. If at this time, circumstances have so altered that it is no longer feasible or prudent to continue the terms of this agreement, the income from this endowment shall be used to further the mission of the University, giving due consideration to the original intent of the donor.

Stewardship:

The Foundation agrees to provide the Donor with periodic reports on the endowment's corpus value, market value, investment earnings, and scholarship disbursements. With the assistance of the University, the Foundation will provide the Donor with the names of student scholarship recipients as well as any publicity or promotional materials available.

General:

This Gift Agreement shall be construed and interpreted so as to be consistent with then existing bylaws and policies of the Foundation. Any dispute relating to the construction, interpretation, or enforcement of this Gift Agreement shall be governed by the laws of the State of Illinois and shall be heard, decided, and resolved in Illinois.

The provisions herein described for *The* < *Donor or Honoree* > *Scholarship Fund* are agreed upon as attested by the signatures below.

This scholarship program, and The Class of 1984 Scholarship specifically, mean a great deal to me. I come from a home where I was discouraged from attending university and was left with little to no way



to finance my academic career on my own. I have worked numerous jobs throughout my college career thus far, but mostly my paychecks would become the gas in my car that took me back and forth to work. It truly would be impossible for me to attend school at Olivet without help like this. Without this scholarship, I would not have been able to return for my final year. It has filled me with such relief and joy that I wish I could express it in more than just words. I mean it with all that I have when I say thank you. I am grateful beyond expression for what this will do for me.

Choosing Olivet

The reasoning behind my parents lack of support to attend college was that they did not want me to leave my daughter behind. Through their protection and concern for me as my parents, I believe that they were unable to see that going to college was going to give my daughter a better life with more opportunities than had I stayed behind. So I made the hardest decision of my life by coming to Olivet--which, in the end, broke the relationship I had with my parents. As my parents had not gone to college, I am also a first generational student. Olivet took me in, a young mother and clueless student, and helped me through everything I needed to be successful. Olivet saw me as more than an ACT score, a GPA, or a number among the rest, but as a student that had potential and that they wanted to succeed and change the world. This is a feeling I experienced on no other campus, so naturally, it was the defining reason I chose to come to Olivet.

My Greatest Learning Experience at Olivet

The greatest thing I learned at Olivet was not in a classroom, but throughout

multiple instances during my years. I learned how to trust God. Coming into Olivet, I had no faith. I was not raised in the church, nor had my mom ever talked about her faith, though I knew she did believe. I was so unaware of God, but open to the possibility of letting Him in. Looking back now, it's laughable how much God was already in my life yet I hadn't even recognized His presence. There have been many trials I have faced here, many trials I believe otherwise would not have ended so perfectly had I not been exactly where I was intended to be. So many times over the past four years an obstacle would present itself with no realistic solutions and rock my world. Sometimes these obstacles would have forced me to drop out of school had God not intervened and miraculously solved the problem in a way that was entirely out of my control. This trust has been the most valuable lesson during my time at Olivet.

My Favorite Subjects

My favorite subject in particular was ornithology. Birds have always been my favorite creatures, dating all the way back to my childhood. If I had the ability to tell my younger self the opportunity I would have to study these creatures in depth, I think my younger self would have been overjoyed. And that was exactly my experience in that class--joy. Even on the freezing cold winter mornings when we would have lab to go into the field. The stretches of cold silence were easily forgotten when a new bird would fly into view for observing. I would love to pursue a career in ornithology, specifically conservational ornithology. If I could protect creation in any way through conservation, I would feel deeply fulfilled.

My Favorite Olivet Tradition

My favorite Olivet tradition may be an odd and niche selection, but it is my favorite nonetheless. Every summer, for 2+ weeks, the Olivet Tiger Marching Band gets together before school starts for their rookie and band camp. This was the place I met many of my best friends for the rest of my years here and beyond. It has been my one huge family from my very first time at Olivet. From the director, to the faculty, to the students--every single person in the band has played a role in my life. I have been pushed, shaped, and caused to grow from my time with the band. It has taught me how to lead humbly and graciously. I will forever cherish those times as I hope the coming and current members will too.
