Olivet Nazarene University (ONU) & Worth It Moments (WIM)

Dates: October 4-9, 2026

Price:

\$3540 is based on shared double room occupancy and includes transportation, entrance fees to sights, and gratuities, and all meals except five. The single occupancy rate for individual travelers without a roommate is \$5140. Estimated flight cost of \$387 per person.

Deposit and Registration:

A non-refundable deposit of \$400 per person is required upon registration. Trip balance must be paid in full by June 1st, 2026

Refunds Upon Cancellation:

Initial \$400 deposits are non-refundable. The refund cancellation (not including deposit) schedule is as follows:

- I. 75% refund on cancellations made 90+ days before the trip*
- II. 50% refund on cancellations 60+ days before the trip*
- III. 25% refund on cancellations made 30+ days before the trip*
- IV. Cancellations within 30 days of the trip are not eligible for a refund*

Insurance:

ONU & WIM highly recommends purchasing insurance for trip cancellation and interruptions.
