Olivet Nazarene University (ONU) & Worth It Moments (WIM)

Dates: May 10-15, 2027

Cost: \$1,650 per person

Price:

\$1650 is based on shared double room occupancy and includes transportation, entrance fees to sights, and gratuities, and all meals except four. The single occupancy rate for individual travelers without a roommate is \$2150.

Deposit and Registration:

A non-refundable deposit of \$250 per person is required upon registration. Trip balance must be paid in full by April 10th, 2027

Payment Schedule:

Nonrefundable Deposit: Due January 1, 2027

- Couple \$500
- Individual w/ roommate \$250
- Individual w/o roommate \$250

First Payment Due: January 13, 2027

- Couple \$1400
- Individual w/ roommate \$700
- Individual w/o roommate \$950

Final Payment: Due March 10, 2027

- Individual w/ roommate \$700
- Individual w/o roommate \$950

Refunds Upon Cancellation:

Initial \$250 deposits are non-refundable. The refund cancellation (not including deposit) schedule is as follows:

- I. 75% refund on cancellations made 90+ days before the trip*
- II. 50% refund on cancellations 60+ days before the trip*
- III. 25% refund on cancellations made 30+ days before the trip*
- IV. Cancellations within 30 days of the trip are not eligible for a refund*

Insurance:

ONU & WIM highly recommends purchasing insurance for trip cancellation and interruptions.

Physical Activity:

You acknowledge and agree that the travel will require moderate physical activity, some stairs, as well as sitting and standing for extended periods of time.
